



- 2. The Trustees have at the request of the settler agreed to act as the trustees.


NOW THIS DEED WITNESSES AS FOLLOWS:

- 3. The Registered office of the trust shall be situated D-90 A, 27 ft" Road, Dabua Colony, Faridabad (Hr.) unless changed by the trustees.
- 4. Area of Operation; Whole of India ____

AIMS & OBJECTS.

The main objects for which the trust is being established are:-

- a. To establish and run, promote, support Educational Institutions of all types i.e schools, colleges, hostels and also other charitable institutions for the education of Boys & Girls in diff" field of learning in the state of Haryana & other part of the Country.
- b. To grant stipends, scholarships, studentship to deserving students.
- c. To construct or alter any building, which may be necessary or convenient for the purpose of Trust.



- d. To purchase, take on lease, accepts as gift or otherwise acquire any land or building which may be necessary or convenient for the purpose of Trust.

The membership shall terminate ispo-facto on account of Death, insanity, insolvency, resignation and voluntary retirement or removal by the managing committee or the chairman of his own for any valid reason.

MANAGING COMMITTEE

- 1. The managing committee shall consist of minimum five members but not more than 11 members.
- 2. The settler of the trust shall nominate the first office bearers and members of the managing Committee who shall work for 3 years. Thereafter the members of the executive committee shall be elected after every three years at the General Body Meeting. The settler hereby nominates and appoints the following person as office bearers at the time of creation of this trust who shall work in accordance with the conditions mentioned herein above:

The settler shall always be a member of executive committee whether an office bearer or not. After the above trustees their legal heirs viz. their spouse or children shall automatically become the trustee.

3. The Managing Committee shall meet at least once in a year, for which a 10 Days notice shall be issued by the Secretary along with the Agenda. 1/3rd member shall form quorum for the meeting. The proceedings of every meeting shall be recorded and duly confirmed in the next meeting. However, an emergency meeting of the trust can be convened at 24 hour notice.

CHAIRMAN:

The chairman shall preside over the meeting of the trust.

The chairman shall be the Chief Executive of the trust and shall be responsible for the general administration of the trust.

The Chairman shall call meetings of the Managing Committee as and when deemed necessary and require by him.

The Chairman shall also operate upon the Trust bank Accounts jointly with either of the Secretary/ Treasurer of the trust.

- b. The life time trustee will have the power to nominate new trustee and cancel the previous nominates with a majority
- c. The trustee can also appoint additional trustee for such period and on such terms as to hold any particular property, fund or investment and may make such rules for the conduct and regulation of their meetings as the trustees may consider proper time to time.
- d. any person who is nominated to be the trustee in succession can also be appointment as additional trustee and such appointment will not affect him in any way to be the successor in office of the trustees.
- e. The trustees may delegate in writing all or any of his powers to his nominee who is entitled so long as such nomination remains enforce to exercise powers in the same manner as the trustee himself could do personally.
- f. the life time trustees / additional trustees shall be chargeable only for such moneys .stock shares and fund they shall not be answerable or accountable for neglect, default, acts of omission or commission of the trustees / additional trustees or any officer employee or agent so appointed or may other person with whom the trust fond may have been deposited or kept may other person with whom the trust fund may have been deposited or kept.
 - g. the trustees / additional trustees will not be untilled to receive any remuneration as trustees / additional trustees but may reimburse himself of all expenses actually incurred by him in connection with the trust or his duties relating thereto.
- 6. The trustees 'additional trustees shall keep or cause to be kept true and proper account of all moneys received and disbursed or spent for the object and purpose of the trust.
- 7. The trust hereby created shall be irrevocable.
- 8. It is expressly declared that no part of the trust properly or its income shall be applied for any purpose which is not a public charitable purpose in law and all the Provisions thereof shall be considered accordingly.
- 9. In the case of dissolution of this trust or its becoming defunct due to some reason or other its assets shall be handed over / transferred to some other trust / organization having aims and objects similar to that of this trust.

GENERAL:

The funds of the trust shall be deposited in any scheduled bank or

- d. To borrow money for the purposes of the trust and management of its properties.
- e. To let our or to demise any immovable property comprised in the Trust Fund for such period and at such rent, or such terms and conditions as the Trustees in his discretion may think fit.
- f: To open account with any bank or banks in the name of the Trust, to operate such account and to give instructions to the bank that such accounts may be operated upon by one or more persons appointed by the Trustees.
- g. To adjust, settle, compromise, compound, refer to arbitration all actions. Suits, claims, demands and proceedings regarding the trust properties, fund or affairs.
- h. To appoint constituted Attorney or Agents and to delegate to such attorneys. Of agents all or any of the powers vested in trustees under these presents and from time to time remove such attorneys or agents and to appoint others in their place.
- i. To appoint or make provision for the appointment of any persons (including the trustees) as member of a committee or as Administrator or otherwise for the purpose of the administration of the Trust in such manner and subject to such rules and regulations as the trustee may prescribe from time to time.
- j. To make, very, alter or modify schemes, rules & regulations for carrying out the objects of the Trust and for the management of the affairs thereof and of running any instruction in furtherance of the objects of the Trust.
- k. To start, abolish discontinue and restart any charity or charitable institution.
- 1. To set apart the whole or part of the income or the corpus of Trust Fund for any of the objects of the trust.
- m. To pay all charges, impositions and other outgoings payable in respect of the Trust fund or any property comprised in the Trust and also to pay all cost of and incidental to the administration and management of the trust for the time being.
- n. To appoint and / or dismiss officers, agents or other employees to look after and manage the properties constituting the Trust Fund on such terms and conditions regarding their duties and remuneration etc. as the trustees may think fit and property
